

## At creek with five friends, youth drowns

An evening out at Chena creek near Ghodbunder in Kashmiria turned tragic for a group of six friends when one of them drowned after the strong water currents dragged him deep inside the creek on Monday evening. The victim, Shivkumar Ramashray Gupta, 22, was a resident of Indralok in Bhayandar East. Attempts by local villagers to rescue him remained unsuccessful. Fire brigade personnel could pull out his body only after a two-hour long search.

"The body has been sent for post-mortem, the reports of which are awaited. An accidental death report has been registered," said an officer attached to the Kashigaon police station.

## Man breaks Atal Setu boom barrier

In a first of its kind incident on Atal Setu, a car driver hit the toll boom barrier to avoid paying Rs200 charge on Monday. The accused, Shoab Ali Khan, 22, who manages the transportation business of his brother-in-law, was on his way to Ulwe from Mumbai. He has been booked under sections 281 (rash driving), 125 (endangering human life) of the Bharatiya Nyaya Sanhita (BNS) and relevant sections of the Motor Vehicles Act. A Nhava Sheva police officer said Khan was returning from Mumbai and broke through the boom barrier as he didn't have toll money. Toll attendant, Adesh Deshmukh, sustained minor injuries.

# MHADA lottery: 2,513 applications until August 13

The Mumbai Housing and Area Development Board, a regional unit of MHADA, has received 2,513 applications for 2,030 lottery apartments in Pahadi (Goregaon), Antop Hill (Wadala), Kopri (Powai), Kannamwar Nagar (Vikhroli) and Shivdham Complex (Malad).

The online registration and application process for the lottery began at noon on August 9. Until 1.38pm on August 13, the Board had received a good response from prospective buyers along with earnest money deposit (EMD).

While an EMD of Rs25,590 has been received in the Economically Weaker Section (EWS) category, Rs50,590 has been received in the Low Income Group (LIG), Rs1 lakh in the Middle Income Group (MIG) and Rs1.5 lakh in the Higher Income Group (HIG) categories.

The deadline for submitting online applications is 3pm on September 4 and the



acceptance of the online deposit amount will be done till 11.59pm. The provisional list of applications received will be published by 6pm on September 9. Objections and claims regarding the provisional list can be submitted online until 12pm on September 9 and the final list of accepted applications will be published by 6pm on September 11. The computerised draw for the lottery will be held at 11am on September 13, the location for which will be announced soon.

The registration, application, and payment process will be available on

MHADA's official website <https://housing.mhada.gov.in>. To participate in the housing lottery, the annual family income limit is Rs6 lakh for the EWS, Rs9 lakh for LIG, Rs12 lakh for MIG and above Rs12 lakh for HIG where there is no upper limit. Individuals from the EWS can apply for houses both in the EWS and LIG categories, while those from LIG can apply for both LIG and MIG categories. Similarly, buyers from MIG can apply for both MIG and HIG categories, while those from HIG can only apply for the HIG category.

## Flat seekers cautioned against fake website

The Maharashtra Housing and Area Development Authority (MHADA) has uncovered a fake website, <https://mhada.org>, which closely resembles the official MHADA site <https://mhada.gov.in>. This fraudulent site has already deceived several citizens, leading MHADA to file a formal complaint with the cyber cell.

Following the announcement of a lottery for 2,030 flats across various housing projects in Mumbai, MHADA's vice-president and CEO Sanjeev Jaiswal urged applicants to exercise caution, and submit applications only through MHADA's official website, as only those who apply through this platform will be considered for the computerised lottery draw. He clarified that MHADA flats are allotted exclusively through this computerised system, which is secure, fully online, and free from human interference.

The fake website mimics the appearance of MHADA's official site but bypasses the legitimate application process, offering direct payment options. Victims were misled into paying Rs50,000 with the promise of securing a flat, even receiving a fraudulent receipt.

MHADA uses the IHLMS 2.0 computerised lottery system, known for its simplicity and security. Once registered on the official platform, applicants can upload their documents, which are verified before the necessary deposit payments. However, in the reported fraud cases, victims skipped these steps and made payments directly.

## ₹2,766 cr for 1,950 projects to mitigate natural disasters

In a recent meeting of the State Disaster Management Authority, Chief Minister Eknath Shinde approved 1,950 projects worth Rs2,766 crore aimed at mitigating natural disasters. The projects include measures for landslide prevention, protection against electrical faults, flood protection walls, small bridge construction, drainage deepening, groundwater recharge, lake maintenance, and afforestation. Additionally, a decision was made to upgrade the State Emergency Response Centre.

The meeting, held in the cabinet hall of the secretariat, was attended by Deputy Chief Ministers Devendra Fadnavis and Ajit Pawar, relief and rehabilitation minister Anil Patil, chief secretary Sujata Saunik, and principal secretary of the relief and rehabilitation department,

Sonia Sethi. Chief Minister Shinde emphasised that funding shortages should not hinder disaster prevention measures and instructed that these projects be completed on time and to high quality standards. He also directed the acquisition of modern technology and equipment useful for disaster response.

At the meeting, it was decided to modernise the State Emergency Response Centre using advanced technology and to enhance connectivity for each district collector. Additionally, district emergency response centres will be upgraded with a fund of Rs100 crore.

Furthermore, approval was granted for the state landslide management plan, village panchayat disaster management plan, Maharashtra state heat action plan, and the Palghar-Vasai underground electrical line project.

## Corporators from BJP meet Gagrani

Sixty former BJP corporators met civic chief Bhushan Gagrani at the civic headquarters on Tuesday to discuss unresolved civic issues such as potholes, civic markets, and crematoriums within their wards. A similar meeting was held last week between 47 Shiv Sena (Eknath Shinde) corporators and Gagrani.

To bolster their public engagement and strengthen their influence, city legislators and former corporators are currently working to resolve pending issues in their wards.

"Topics discussed included delays in repairing or reconstructing public toilets, the lack of Aapla Dawakhana clinics in some areas, and pending beautification of various gardens," said guardian minister Mangal Prabhat Lodha. A few former corporators requested the establishment of new hospitals in their respective wards.

## Special HC bench for Slum Act's audit

The Bombay High Court on Tuesday constituted a special bench to undertake a "performance audit" of the Maharashtra Slum Area (Improvement, Clearance and

Redevelopment) Act, 1971. Chief Justice DK Upadhyaya issued a notice constituting the special bench pursuant to the Supreme Court directions on July 30. Presided over by Justice Girish Kulkarni, the bench will take up suo motu proceedings on August 16.

The SC had asked the HC chief justice to set up a bench to "initiate suo motu proceedings" to conduct a performance audit of the state slum redevelopment law, noting that the "welfare legislation for the poor is gridlocked and 1,600 cases are pending.
